Indeed the doctor was arrested last year on exactly this charge, but the CPS / police dropped the case. It would require a parliamentary override to be legal, and that has never existed. There are no exemptions to the laws of England and Wales for religious or cultural considerations. It follows. as night follows day, that both the doctor and the grandmother in this case are criminals, and should be prosecuted.
